ORDINANCE #2015 - 01

AN ORDINANCE AMENDING THE CODE OF ORDINANCES OF THE CITY OF GLIDDEN, IOWA 2012. BY AMENDING PROVISIONS PERTAINING TO RATES FOR ELECTRIC SERVICE.

Be It Enacted by the City Council of the City of Glidden, Iowa:

SECTION 1. SECTION MODIFIED. <u>Chapter 111. Section 05. Paragraph 3 of the Code of Ordinances of the City of Glidden, Iowa, 2012, is repealed and the following adopted in lieu thereof:</u>

111.05 RATES. The rates for electric service shall be as follows:

1. Residential Rate. Applicable to residential customers for all domestic uses in single family dwelling and individually metered apartments including use of motors of not more than five horsepower (5 H.P.) individual capacity. Water heating units shall not exceed five (5) KW simultaneous capacity and shall be uncontrolled hereunder. Space heating may be served under this rate schedule when applicable to dwellings.

Customer charge:

Single phase

\$15.00 per month

Three phase

\$25.00 per month

Energy charge:

\$0.0913 per kWh

Minimum Bill: The applicable customer charge (\$15.00 or \$25.00).

2. <u>Commercial Rate</u>. Applicable to commercial and small industrial consumers for lighting, heating, cooking, refrigeration and power to motors.

Type of Service: Single phase and three phase, 60 cycles, at available secondary voltages. Motors having a rated capacity in excess of ten (10) H.P. must be three phase.

Customer charge:

Single phase

\$15.00 per month

Three phase

\$25.00 per month

Energy charge:

\$0.0913 per kWh

Minimum Bill: The applicable customer charge (\$15.00 or \$25.00).

Industrial Rate. Available to any customer whose normal demand is twenty-five (25) KW
or more, provided the entire requirements are taken through one meter; not applicable to
resale, standby, temporary, supplemental, auxiliary or shared service. City furnishes only
one transformer installation.

Customer Charge

\$50.00 per month

Demand Charge

\$11.19 per kW

Energy Charge

\$0.0404 per kWh

The total bill is the sum of the customer, demand, and energy charges.

An industrial rate is applied to those customers who utilize twenty-five (25) KW or more at any time or whose business use will potentially have the capability of requiring demand power on the system.

Minimum Bill: \$329.75 per month (the customer charge and 25 kW demand charge)

The City Utilities reserves the right to negotiate Industrial Rates with governmental agencies and certain economic development projects.

4. Municipal Rate. Applicable to municipally owned facilities.

Customer charge:

Single phase \$15.00 per month Three phase \$25.00 per month

Energy charge: \$0.0796 per kWh

5. <u>Street Lighting</u>. Applicable to all controlled multiple street lighting from dusk to dawn. Base rate per luminary per month.

<u>High Pressure Sodium</u>	Per Luminary
150 Watt	\$ 7.50 per month
250 Watt	\$11.00 per month
400 Watt	\$16.25 per month
LED (60)	\$ 3.00 per month

Additional Charges: The above charges apply to luminaries mounted on brackets on distribution poles and where no additional poles are required for street lighting circuits. A charge of *one dollar* (\$1.00) per month per wood pole will be added to the total charge, as determined above, for each additional pole required. Ornamental metal poles will be charged at the rate of *five dollars* (\$5.00) per month for each pole required.

SECTION 2. SEVERABILITY CLAUSE. If any section, provision or part of this ordinance shall be adjudged invalid or unconstitutional, such adjudication shall not affect the validity of the ordinance as a whole or any section, provision or part thereof not adjudged invalid or unconstitutional.

SECTION 3. WHEN EFFECTIVE. This ordinance shall be in effect from and after its final passage, approval and publication as provided by law, with the new rate structure applied to all utility bills dated June 30, 2015 and all thereafter.
